



DOCUMENTS NEEDED FOR ACCOUNT VERIFICATION

All the documents mentioned below should be submitted when opting for a Corporate Account:

- Certificate of Incorporation
- Evidence of registered address and trading address (see B above); and
- List of all the shareholders both legal and beneficial of the entity or undertaking from lawyers or accountants if documents are unavailable; and
- Board Resolution or similar documents authorizing named individuals to deal with the firm; and
- Memorandum and Articles of Association or equivalent constitution documents establishing the legal basis of the entity; and any amendments to those original documents;
- Any documents which trace and demonstrate full current ownership and control of the entity (if
 documents are not available, an undertaking of a lawyer or accountants of the shareholder's list both
 legal and beneficial of the entity); and
- Latest report and accounts; or a letter of good standing from the bank; and
- Full personal identification materials for directors and beneficial owners or controllers of the entity (see further below).
- Evidence of ID (see A below); and
- Evidence of address (see B below); and
- Evidence or Description of Source of funds.



DOCUMENTS NEEDED FOR ACCOUNT VERIFICATION

- A) For **Proof of Identity**, you can submit any one of the four mentioned documents:
- Current passport showing your clear picture and signature.
- Current driving license /national driving permit showing your clear picture and signature.
- Other official identification card showing your clear picture and signature (e.g. armed forces)
- Firearms certificate showing your clear picture and signature.
- B) For **Proof of Residence**, you can submit any one of the three mentioned documents:
- Building society, bank account statement received within the last 3 months and sent to your residential address (e.g. mortgage, savings or current account statement, Credit card statements are not acceptable)
- Utility bill (e.g. water, gas, electricity) or certificate from a supplier of utilities confirming the prepayment arrangements received within the last 3 months and sent to your residential address. (Mobile phone bills are not acceptable)
- Demand or correspondence from tax authorities (including local tax authority) received within the last 3 months and sent to your residential address (e.g. council tax).

You need to upload the documents to the NoaPrime Client BackOffice within 3-5 business days from the date of account submission.



Once you have completed the application, NoaPrime will verify the details before approving your trading account. If your account is not approved due to any outstanding document or any other reasons, you will receive an email notification with the details from the support team.
